

COVID-19 Layered Mitigation Protocols: 2021 - 2022

The Watervliet City School District is planning for a full return to school in September, providing strong academics and an array of extracurricular and athletic offerings. The district will use a layered mitigation approach to address the health and safety concerns of the COVID-19 pandemic.

This is about carefully monitoring the various stages and implications of COVID-19. A measured approach will be taken to make adjustments to mitigate efforts based on the transmission or rate of infection based on CDC levels of community transmission.

The intent of the layered approach is to maintain a balance between prioritizing health and safety of students and staff, and supporting the social, emotional, mental health of students and staff.
