SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. The district engaged in conversation with stakeholders several times through the development of the ARP plan. The administrators', teachers', and support staff's unions were included and represented in dialogue pertaining to the development of the plan. Each union provided drafts of ideas to take into consideration. A virtual community forum was held on June 10, 2021, along with several Board of Education meetings to gather input and consult with students, families, and staff. The district also gathered feedback from all stakeholders with an online survey. https://www.watervlietcityschools.org/district-seeks-input-on-covid-relief-funding-community-forum-set-for-june-10/
Stakeholder input from parents and the community identified the urgent need to support full day programming for our Universal Prekindergarten students; this was added as a priority for the use of funds. Other stakeholders, including Board of Education members, identified the benefit of having a School Resource Officer program in the district; this program was added as a priority for the use of funds. Several supplies and materials were identified from the stakeholders (teachers, administrators, staff, and union members) to benefit student access to technology devices, curriculum materials, and promoting student safety. With stakeholder input, the need of stand-by generators in both schools was identified due to the use of the school buildings as community shelters.

The district will continue to engage stakeholders throughout the implementation of funds with routine public forums at least every 6 months in conjunction with regularly scheduled board of education meetings and gathering feedback on the use of funds with an online survey.

In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.

The ARP plan includes the salaries for two additional bus drivers needed to increase student bus route and prevent overcrowding of the school bus. Following CD guidance, these additional routes will allow the district to maintain only two students per seat and provide a staggered schedule for the elementary, middle and high school students. The funding will provide devices (Chomebooks, Google Console License, and Earbuds) for students to be able to transition to remote learning at a moments notice. Lysol disinfectant wipes will be provided to all classrooms for students and staff to mitigate the spread of viruses by disinfecting desks and work spaces. Carpets for student entrances will be used to assist in providing a safe entrance to school with sprays of hand santitizer on all students hands. A maintanence vehicle will be purchased to assist in delivering supplies and PPE, along with providing the maintance workers with transportation between building to align with the mitigation protocols of santitizing high touch surfaces. Additionally, Air Handler Units will be upgraded/replaced in several large spaces to increase the circulation of air flow, these spaces include the gymnasiums, band rooms, and classrooms.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district will utilize a wide-range of student data to monitor progress. In conjuction with the district's DCIP planning, attendance and graduation rate are important factors of student support. Academic data will also be used, incluing the NYS 3-8 ELA and Mathematics assessments and Regents data in conjunction with district-wide benchmark assessments using STAR 360 Early Literacy, Reading and Mathematics online assessments. This data will drive the interventions and supports for students. For grades K-5 this intervention will include tiered Reading and Math academic support groups leveled by individual student needs. For grades 6-12 this intervention will include push-in academic intervention support to ELA and math classes to support student needs.

Routine progress monitoring will occur monthly with online computer adaptive STAR 360 Early Literacy, Reach and Mathematics assessments. This progress monitoring will assist in identifying intervention strategies and academic skills to focus on with students.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

In addition to the planned interventions and support above in number 4, the district will address the impact of lost instructional time with several evidence-based interventions. Long-Term certified classroom teachers (\$182,190) will be utilized over the course of three years to provide academic tutoring and intervention services to students before or after school. Afterschool blub advisors (\$36,000) will provide learning enrichment for students in a variety of content areas. Math manipulatives (\$3,540), online curriculum subscription (\$30,000), and textbooks (\$28,950) will give students additional resources to meet success with interventions. The district will use funds to extend the Universal Pre-Kindergarten programming for students to provide a solid foundation for students in a full-day program (\$567.000).

Additional ARP funds will be used to provide SRO services through the City of Watervliet Police Department (\$180,000) to provide safety and security to the students. It will be monitored in collaboration with the City of Watervliet officials and presented to the Board of Education annually.

Update the districts security cameras/recorders (\$69,719) with new licenses. This will be monitored by administrator use of the security features. Add two FTE bus drivers to the transportation department to ensure the safe transport of students to and from programming (\$83,200). Additional bus runs will be monitored by the transportation supervisor, in compliance with the COVID-19 mitigation protocols approved by the Board of Education. Purchase of Chromebooks, Google Chrome management console, Chromebook power cords, and earbuds for student use to ensure one-to-one device capabilities and access (\$118,405). One to one devices will be monitored by the Director of Technology to ensure that every student has access to a device and accompanying hardware.

Add communication radios for district school buses to ensure constant communcation with bus drivers (\$10,000). This will be monitored by the transportation supervisor in order to ensure communication between and among drivers.

Lysol disinfectant wipes will be provided to all classrooms for students and staff to mitigate the spread of viruses by disinfecting desks and work spaces (\$7,671). Use will be monitored by the maintenance supervisor along with teachers and staff in classrooms.

Carpets for student entrances will be used to assist in providing a safe entrance to school with sprays of hand santitizer on all students hands (\$7,605). Monitored by the maintenance supervisor.

Employee Benefits (\$131,024)

Renovate garage/storage location to provide additional storage space (\$700,000) for outdoor learning equipment and maintanence vehicles. Monitored by the business manager to ensure adequate facilities.

A maintanence vehicle will be purchased to assist in delivering supplies and PPE, along with providing the maintance workers with transportation between building to align with the mitigation protocols of santitizing high touch surfaces (\$75,000). Monitored by the business manager and maintenance supervisor to ensure operations between buildings and provide delivery of supplies and materials.

Add stand-by power generators (\$520,000) for both school buildings to provide shelter space in the event of an emergency. Monitored by the business manager to ensure adequate facilities.

Add electronic signs (\$120,000) for both schools to increase community/parent communication. Monitored by the communications specialist to provide additional means of notification to the community.

Air Handler Units will be upgraded/replaced in several large spaces to increase the circulation of air flow, these spaces include the two gymnasiums, band room, and one classroom (\$160,000). Monitored by the maintenance supervisor to ensure clean air and circulation for students.

7. The district's steering committee (shared decision making team) meets quarterly to analyze and dissegregate data. This committee will monitor student data to ensure that the district is responding to the academic, social, emotional, and mental health needs of all students. This will include the implementation of the school culture and climate survey, along with the analysis of the survey results.

In addition, each school building's Equity Team will ensure that the interventions implemented focus on those students disproportionally impacted by the pandemic. This team works closely with the ENL teachers, Director of Special Education, Homelessness Liasion, and Outreach Coordinators to ensure interventions and the use of funds impact the academic, social, emotional, and mental health needs of students from low-income families, English language learners, students with disabilities, and students experiencing homelessness. Each of these four student subgroups are found within the district.

Recommendations for the use of ARP ESSER funds will be made by the equity teams to the district's steering committee and subsequently to the board of education.
