- 1. Anyone signing must be a <u>duly qualified</u> <u>voter</u> of the Watervliet City School District.
- 2. An individual can sign more than one candidate's petition.
- 3. The <u>entire</u> petition must be completed.
- 4. A <u>minimum</u> of 100 valid signatures must be collected.
- 5. Completed petitions must be signed and <u>notarized</u>.
- Petitions must be returned to the Office of the District Clerk <u>no later than 5:00 p.m.</u> <u>April 30, 2025</u>.
