School budget vote set for May 20

Proposed budget focused on teaching and learning to meet student needs, tax levy increase below 'cap'

On Tuesday, May 20, Watervliet City School District residents will vote on a proposed \$44,082,000 budget for the 2025-26 school year. Voters will also consider a bus lease proposition, a proposed library tax (see page 3), and will elect one candidate to the Board of Education. Voting will take place from 11 a.m. to 8 p.m. at two polling locations: Watervliet Elementary School and the Watervliet Elks Lodge (see page 4).

The budget proposal calls for an increase of nearly \$2.7 million or 6.5% compared to the current year. It will allow the district to maintain all personnel, programs and services. The projected state aid increase of \$2 million will help offset spending and invests in supports to address the needs of all students.

A reduction in state building aid qualifies the district for a capital levy exclusion, which would yield a maximum allowable tax levy limit of 15.44% per the state's tax "cap" calculation. District leadership has chosen instead to present a budget with a **much lower 1.77% tax** levy increase. This is possible because of the district's strategic approach to

long-term fiscal stability, which includes setting aside funds to address disparities in state building aid and the district's debt service payments without shifting the burden to taxpayers.

School tax rates, which determine the amount property owners pay per \$1,000 of assessed value, are set when the City provides its final tax assessment data to the district in August.

Budget prioritizes student needs

The proposed school budget continues to prioritize teaching and learning. It provides resources to meet the academic needs of students and supports for social-emotional development. The budget proposal includes the following:

 Addition of a school counselor, athletic director, special education teacher, part-time art teacher and part-time speech therapist.

 Rental of classroom space to relocate the EVOLVE program to Green Island's Heatly School.

 Increase in professional development for teachers with instructional coaching K-12.

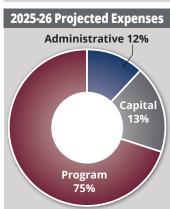

said Superintendent of Schools Dr. Donald Stevens. "It invests in strategies that strengthen academics, streamline operations and enhance safety. Most of all, it aligns with our mission to educate, inspire and challenge every student, every day."

PROPOSITION 2: SCHOOL BUS

 Residents will decide a referendum to lease one 66-passenger bus for five (5) years at an annual cost of \$26,600.

PROPOSITION 3: LIBRARY TAX

• Residents will vote on a proposition to authorize the school district to levy a tax of \$200,000, an increase of \$50,000, to support the Watervliet Public Library's programs. As per NYS education law, libraries are permitted to place a funding proposition on the school district's ballot that would require the district to levy and collect taxes for the library. The proposed library tax is NOT part of the school district's budget. Please visit our website for more information.

^{*} If the proposed budget is defeated on May 20, the Board of Education will have three options: present the same budget to voters a second time; present a revised budget to voters; or adopt a contingent budget. If the budget is again defeated, the board must adopt a contingent budget. Under the tax levy limit law, school districts can levy a tax no greater than that of the prior year, or a 0 percent increase, in a contingent budget. The Watervliet City School District would be required to eliminate an additional \$137,000 in proposed spending for the 2025-2026 school year.

Voting information

- ✓ You are eligible to vote if you are a U.S. citizen, at least 18 years old, registered with the Albany County Board of Elections, and a resident of the school district for at least 30 days prior to the vote date.
- ✓ Absentee ballots: Residents who wish to vote by absentee ballot may pick up an application at the district office. Qualifications for voting by absentee ballot include: will be out of the county on the day of the vote; unable to appear in person due to permanent illness or disability.
- ✓ Early Voting: Eligible voters may apply for an early voter ballot for the school budget and board of education election by completing an application, which can be requested from the District Clerk.

Polling sites for the Tuesday, May 20 vote

For the school budget vote and Board of Education election on May 20, eligible voters will cast their ballots at one of the two locations below:

- ✓ District 1 Watervliet Elks Lodge, 501 4th Avenue All locations in the district south of the northernmost wall of the Arsenal and the entire area of Mannsville.
- ✓ District 2 Watervliet Elementary School, 2557 10th Avenue

 All locations in the district north of the northernmost wall of the Arsenal.
